 - State Meet Entry Fees
 - Kristy recused from discussion and decision
 - 2023- Ohio USAG State Championships Entry Fees:
 - Xcel: \$100

- Compulsory: \$100
 - Optional: \$115
 - Decision: To be requested from RACC to remain the same as 2023.
 - Approved by RACC
 - Judge Criteria
 - Ratings: Judging Criteria: may be determined by the SAC.
 - A Level 7/8 rating is required for Platinum and Diamond Divisions.
 - A minimum of Level 9 rating is recommended for Diamond Division
 - A minimum of Level 9 rating is REQUIRED for Sapphire Division.
 - If there is a lack of qualified judges, the assigner must contact the RTCC for permission to assign a lower rated judge, if necessary.
 - Panels- Xcel Mobility
 - Recommendation: two-judge panels.
 - For mobility purposes, one-judge panels ARE ALLOWED at all Divisions.
 - An affiliated judge may be used.
 - There may not be more than one judge per panel with the same affiliation
 - Proposed
 - 1-judge panel allowed Gold- Platinum
 - Motion- Michelle Crane
 - 2nd- Jill Skulich
 - Vote- passed unanimously
 - 2-judge panel required from Platinum-Diamond-Sapphire
 - Motion- Michelle Crane
 - 2nd- Jill Skulich
 - Vote- passed unanimously
 - Divisions at State Championships for Compulsory and Xcel
 - Remain the same as last year. We will maintain divisions for the TEAM Competition. Individuals at the same level will compete against all other individuals in their age group at that level, without a division separation
 - Aim to schedule where the least overlap is possible for level 3 and 4
 - No proposal to change, no vote needed
 - \$2000 contribution from OH SAC to Optional State Meet host for 4-judge panels
 - No proposal to change, no vote needed
 - Placements at State Meets (also age group size determination)
 - Maximum age group size- 20
 - 33% event placement, Top 10 AA
 - No proposal to change, no vote needed
- Regional Judges Rankings
 - Discuss new process
 - 3 different rankings- 1 for each regional meet. Take into account PIF information- Consider volunteer positions, time with athletes, judgements/assignments at the particular levels for which they submitted
 - Top 20 for each meet will be submitted from each individual- Note: Can only submit ranking if not available for that particular competition
 - Once Top 20 from each individual is submitted, the aggregate list will be completed and Top 20 for each competition will be submitted to the Regional Administrative Committee Chair

- State Meet Assignments
 - Ohio will allow judges to update their availability for State Meets after PIF has been submitted. Note: PIF must have been submitted by the deadline
 - Motion- Rachael Tracy-Gardner
 - 2nd- Teresa Principi
 - Recused- Jill, Kristin
 - Vote- passed unanimously

- More discussion items
 - Further discussion to be had on randomization of rotations at State Championships
 - State Championship Judge Assigning Process- will be detailed and posted. Will follow the same steps as the Regional ranking process.
