- Awards
  - o State Qualifier Gift
    - Small banner last year-continued for this year
  - Placements
    - Age group size: 20 athletes maximum
      - Top 10 All around
      - 33% Events
      - ALL Levels including Xcel
      - Every athlete receives qualifier banner
- Discussion
  - Divisions at compulsory and Xcel State Meets
    - Committee determines to remove divisions for individual competition- all athletes at each level compete against their own age group- regardless of gym size.
    - Discussion: Team awards- Team awards split by number of athletes competing in that particular level- names to be determined
- State Team
  - Xcel
    - Determined by Tuesday following the event
  - Level 6-8
    - Must be determined based on age groups determined by region. Timeline dependent on other states dates of State Meet
- Judges Selection Discussion
  - Recusal from the selection will be required for any judges with availability for the state meet in question
- Annual Housekeeping
  - NAWGJ is our assigned governing body for USAG Sanctioned events in the state of Ohio

- State Budget Review
- Athlete Competition Tax
  - Only on each athlete that COMPETES at a meet
  - Michelle Motions: Every athlete competing at sanctioned meet in Ohio- a \$1 'athlete tax' charge will be due from the Meet Host within 14 days of completion of the event
    - Jasmine 2<sup>nd</sup>
    - Unanimous
  - Penalties detailed
    - If not paid by deadline (14 days following the event)- SACC will contact meet host for payment
    - If payment not remitted within 30 days, any future event hosted by the meet host will not be eligible for state qualification or mobility until paid in full. Additionally, the host will not be eligible to host a state meet until paid in full.
- Single Occupancy Rooms for Judges
  - James Motions: Single occupancy rooms required for judges at ALL Ohio State
    Championships
  - Kristin: 2<sup>nd</sup>
  - Unanimous
  - Invitationals: Follow R&P requirements and recommendations: Chapter 5 Page 43
    Section C.2
    - Please be sure to note standard IRS overnight accommodation for Ohio is \$202 per room night
- Judging Requirements
  - Xcel- following R&P for Xcel Ratings
    - A Level 7/8 rating is required for Platinum and Diamond divisions.
      - A minimum of Level 9 rating is recommended for Diamond division.
  - Xcel Mobility
    - 1-judge panels are permitted for mobility from Gold to Platinum
    - 2-judge panels are required for mobility from Platinum to Diamond
  - Xcel State Qualifications
    - 2-judge panels are required for Silver and above
    - 1-judge panel is permitted for Bronze state qualification
- Compulsory (Level 2-5)- ratings determined by R&P
  - Compulsory Mobility
    - 1-judge panels are permitted for mobility from Level 4 to Level 5
    - 1-judge panels are permitted for mobility out of Level 5
  - Compulsory State Qualifications
    - 2-judge panels are required for Level 3 and above
    - 1-judge panel is permitted for Level 2 state qualification

- Optional (Level 6-10) ratings determined by R&P
  - Optional mobility follows R&P
  - Optional State Qualifications
    - 2-judge panels are required for all levels

  - Level 6-10: Monday, February 13<sup>th</sup>
  - Level 2-5: Monday, February 20<sup>th</sup>
  - Xcel: Monday, February 27<sup>th</sup>

  - R&P Maximums
    - Comp: \$85
    - Opt: \$95
    - Xcel B-G: \$85
    - Xcel P/D: \$95

- Apparel
  - State Teams
    - Motion: Kristin G- Provide a leotard and t-shirt to state team members
    - 2<sup>nd</sup>: Jasmine
    - Unanimous
  - Instead of providing leggings for each state team member- it has been suggested we provide a "State Team Member" badge or pin of some type to denote qualification to state team
    - Pricing for badges, pins, bag tags will be quoted, and the item will be selected from there
